#### **Meeting Notes**

Valencia Bikeway Improvements

- Project began on February 18
- Primary goal is to improve bicycle safety, reduce collisions through better curb management and traffic enforcement
- Project stretches for 2 miles on Valencia
- Double-parked cars are a major issue.
- SFMTA doing research:

- Conducting survey of businesses along the corridor to learn about their needs & perspective - so far 40% response rate
- Reached out to 45 neighborhood groups, so far talked to 25
- Also engaged consultant, who is implementing camera survey (collect video over
   72 hr period in 5 locations along the corridor)
- Public workshops will be held in 2-3 months.
- Improvements already made include 1' bike lane buffer and flex post delineators near intersections with most collisions. So far no impact to parking.
- In response to questions from board members:
  - No further red lanes are currently planned.
  - SFMTA is attempting to engage with TNC companies to partner on this.
  - o Bicycles are not permitted on the sidewalk and changing this isn't on the table.

### Map 2020 Update

- Goals: stem the loss of businesses that serve low to moderate income households in the Mission.
- Proposed zoning modifications:
  - Mission Alcohol Special Use District (covers most of Mission east of Mission St)
    - Conditional use authorization required for restaurant serving alcohol (makes interim control permanent).
    - Conditional use authorization for tasting rooms (i.e. breweries, wineries).
    - Prohibit new Type 75 alcohol licenses (restaurants w/accessory brewing).
  - Mission NCT District (area around Mission St)
    - Limit number of restaurants & bars to 25% of storefronts
    - Limit storefront mergers to spaces no larger than 1500 sqft
    - Promote supply of smaller storefronts (<1500 sqft) in new developments
    - Conditional use required for replacement of legacy businesses
    - Allow light manufacturing
    - Allow non-retail professional services on 3rd floor and above
    - Additional guidance for planning commission on new restaurants (includes things like retaining physical characteristics, local hiring practices, etc.)
    - 2 & 5 year check on impact of these modifications
  - South Van Ness (from 14th 18th)
    - Extend PDR protections to smaller businesses (<2000 sqft)</li>
    - Extend Prop X protections to 8 additional existing PDR businesses in this area
- Other notable changes:
  - New crosswalks on 16th
  - 22 bus will be rerouted to Mission Bay
- MDNA member feedback:
  - Promoting smaller retail spaces is a good idea, larger businesses most likely to fail.

- More basic services are needed (dentists, accountants, etc.)
- Dolores median enforcement should be more clearly codified

#### Sheehy visit

#### • SB827

- Sup. Sheehy did not support Sen. Wiener's draft, but is generally in favor of the idea behind it. Key changes he would make:
  - Amend height down, require a higher % affordable, reduce area of city affected, delay implementation to 2021
  - Ensure planning process is unaltered, design standards are met, etc.
- Sup. Sheehy believes we can be pro-density while preventing abuses.
- Board members raised concern about water & sewage infrastructure being strained by too much density.

#### Homelessness

- Sup. Sheehy supports Prop D a 1.7% tax on commercial landlords, which generates \$1B over 10 years for homelessness services and affordable housing construction.
- o He also supports Sen. Wiener's conservancy bill.
- He points out that the amount of information required to get access to housing is prohibitive for some homeless and this process should be simplified.
