Minutes

- 1. Approved
- 2. Ryley Johnson and Amy Sinclair explained in detail how CleanPowerSF works with PG&E to offer green solutions including wind power and solar energy to San Francisco. They also explained the cost and how to sign up for the program.
- 3. MDNA Board Member, Lucia Bogatay gave a presentation on the SF Community Music Center's plan to expand the non profit music program to a newly purchased building next store to their main building on Capp Street. Lucia explained that they needed our support because the new

- building had been Ellis Acted. The board decided to support the expansion and write a letter of support after hearing about all the free educational opportunities the Community Music Center has been offering both children and senior citizens since 1921, almost 100 years. The vote was unanimous.
- 4. The board reviewed a new proposed sign for the pollinator garden at the entrance to the Dolores Street Median at Market Street. While the board showed its continued support for the garden, most members didn't like the old or new sign and asked board member Patricia Algara, who did the presentation, to see whether the donors would either accept a smaller sign or no sign at all. The board's objections included that the sign was too big, distracting to the beauty of the median, and objected to the name Pollinator Garden, when Dolores Street Median is the actual name.
- 5. It was announced that the Mission Dolores GBD petition has been extended, since doesn't have enough support. The update info was acquired from the MD-GBD website.
- 6. Peter Lewis announced that the adopted Mission Dolores Historic Context Statement and Survey would be reviewed by the HPC at the end of summer. The Planning Department will do the presentation. Rafael Mandelman has indicated that he will nominate an historic district within the neighborhood after that time.
